Times Gone By

40 Years Ago

March, 1964

The Feb. 16th Ice Run at Beaverton had 44 entries. BTD (best time of day) went to Ben Appleby in a SAAB 750 GT. Nineteen of the cars entered were British, sixteen were American & most of those were Corvairs; the balance were Swedish or German. The February 25th SVSCC Meeting would have guest speakers from Chrysler Corp. Chief driver Scott Harvey & competition crew chief Carl Pruese brought a rally film, stories & their special 250hp Valiant GT for inspection. Karl Goering, a GM engineer from SVSCC, wrote about navigating for Donald Skinner of Cleveland, Oh., in the Canadian Winter Rally. They were in a Volvo. The Unlimited Class of vehicles in the March 1 Ice Run, were: a Volvo with spikes, a C-Jaguar with chains on all 4 wheels, and a Corvair with snow tires. Jerry Bloom driving the Volvo had BTD.

30 Years Ago February, 1974

Freezing rain greeted the 46 cars which departed from the Holiday Inn in Grayling for the start of The Sno*Drift Rally. It was won this year by Gene Henderson & Ken Pogue in a Jeep Wagoneer. SVR was well represented at the event with at least 6 teams, plus all of the crew members and numerous control workers. The highest finishing team was Dale McAlister & John Crawford in a SAAB 99 at 12th place. No ice runs yet this year due to the poor conditions at Beaverton.

March, 1974

SCCA established energy saving measures i.e. an overall fuel consumption reduction of 36.6 % for the four pro series, Can-Am Challenge Cup, Formula 500 Championship, Trans-American Championship & the VW Gold Cup. To accomplish this task, SCCA would reduce the number of events, reduce race lengths and shorten practice & qualifying periods.

SVR had 8 new members, including Clark Bond, Bay City & Dave Stavenger of Midland. Clark worked at GM & drove an Opel. Dave was a research chemist at Dow Chemical. Both expected to run rallies together in SVR events. "Inside Info" by Judy McAlister was biographical article on club members. Judy wrote about Doug Eads, who with Fay Meerzo & Harold Nadler, were instrumental in getting an SCCA charter for the Saginaw Valley Sports Car Club. Doug was so interested in racing sports cars, that he took lessons from Martin Tanner. That was good because martin was well known in mid Michigan as a racer. But the lessons were given at 4:30 am on the local cemetery roads!

20 Years Ago February, 1984

The Sno*Drift XVIII was won by Rod Millen & Mike Parris in a Mazda. Saginaw Valley Region had 8 teams entered. The MIPR – '84 event was forming with Rally Master, Brian Rebney; Registrar Barb Bond; Chief of Controls Janet Little; Timing & Scoring, Don Jekel; Authority Liason, Chuck Fortino; & hospitality Coordinator, Deb Spicer. Ice Runs were in full swing with events on Jan. 14 & 15.

March, 1984

The SVR Annual White Elephant Sale was scheduled for the April 4th General Meeting. Ice Runs were over after only 2 events due to the warmer weather.

10 Years Ago February/March, 1994

Don Crawford & Dave Spinnett wrote about press passes & visit to the Detroit Auto Show. SVR now had 89 members. Lynn Weber was planning a Solo II shop seminar at Hub Tire in St. Johns, Mi.







Discussion of Most Improved Driver Award.


