#### SVR Celebrates 50<sup>th</sup> Anniversary in 2017

SVR expects to have a 50 Year Anniversary Celebration at Plymouth Park in Midland, MI on Saturday, July 29, 2017. Originally, the Saginaw Valley Sports Car Club was formed as an independent car club in 1958. The nearest SCCA club was Northeast Michigan Region (NEM) at Flint – Grand Blanc, then Detroit or Western Michigan Regions. Beginning in 1966, SVSCC began talks with SCCA, NEM & Detroit Regions to form SVR in the counties of Saginaw, Bay & Midland. SVR became Region # 100 on January 1<sup>st</sup>, 1967.

**CALL TO ORDER:** The meeting was called to order by Mike Burgess at 7:47 PM. Steve Alger made a motion, seconded by Lisa Burgess to approve the October meeting minutes. Motion passed.

**MEMBERSHIP REPORT:** 116 members.

**TREASURER'S REPORT:** All bills paid to date.  
Troy and Sheri Wolford are following up with the airport on the cost to repair the landing light.
